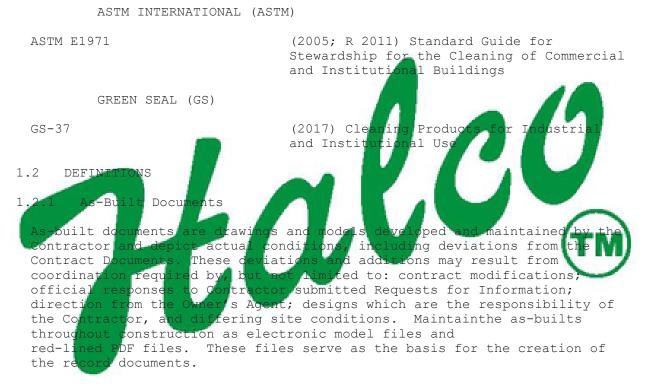

ch contains information relev Develop a M varranty management plan whi ty of Construction At least 30 days before the conference, submit one set of the warranty management -21 Warranty of Constru FAR 52.246 planned pre-warranty Include within the warranty management plan all required actions plan. and documents to assure that the Architect or Owner receives all warranties to which it is entitled. The plan must be in narrative form and contain sufficient detail to render it suitable for use by future maintenance and repair personnel, whether tradesmen, or of engineering background, not necessarily familiar with this contract. The term "status" as indicated below must include due date and whether item has been submitted or was accomplished. Warranty information made available during the constructionphase must be submitted to the Owner's Agent for approval prior to each monthly pay estimate. Assemble approved information in a binder and turn over to the Architect or Owner upon acceptance of the work. The constructionwarranty period will begin on the date of project acceptance and continue for the full product warranty period. A joint 4 month and 9 month warranty inspection will be conducted, measured from time of acceptance, by the Contractor, Owner's Agent and the Customer Representative. Include within the warranty management plan, but not limited to, the following:

a. Roles and responsibilities of all personnel associated with the warranty process, including points of contact and telephone numbers within the organizations of the Contractors, subcontractors,

- b. Furnish with each warranty the name, address, and telephone number of each of the guarantor's representatives nearest to the project location.
- c. Listing and status of delivery of all Certificates of Warranty for extended warranty items, to include roofs, HVAC balancing, pumps, motors, transformers, and for all commissioned systems such as fire protection and alarm systems, sprinkler systems, lightning protection systems, etc.
- d. A list for each warranted equipment, item, feature of construction or system indicating:
 - (1) Name of item.
 - (2) Model and serial numbers.
 - (3) Location where installed.

 - (4) Name and phone numbers of manufacturers or suppliers.
 (5) Names, addresses and telephone numbers of sources of spare parts.
 (6) Warranties and terms of warranty. Include one-year overall warranty of construction, including the starting date of warranty of construction. Items which have extended warranties must be indicated with separate warranty expiration d (7) Cross-reference to warranty certificates as a

- g. Copies of instructions to be posted near selected pieces of equipment where operation is critical for warranty and/or safety reasons.

1.7.2 Performance Bond

The Performance Bond must remain effective throughout the construction period.

a. In the event the Contractor fails to commence and diligently pursue any construction warranty work required, the Owner's Agent willhave the work performed by others, and after completion of the work, will charge the remaining construction warranty funds of expenses incurred by the Architect or Owner while performing the work, including, butnot limited to administrative expenses.

- b. In the event sufficient funds are not available to cover the construction warranty work performed by the Architect or Owner at the Contractor's expense, the Owner's Agent will have the right torecoup expenses from the bonding company.
- c. Following oral or written notification of required construction warranty repair work, respond in a timely manner. Written verification will follow oral instructions. Failure to respond will be cause for the Owner's Agent to proceed against the Contractor.

1.7.3 Pre-Warranty Conference

Prior to contract completion, and at a time designated by the Owner's Agent, meet with the Owner's Agent to develop a mutual understanding with respect to the requirements of this section. Communication procedures for Contractor notification of construction warranty defects, priorities with respect to the type of defect, reasonable time required for Contractor response, and other details deemed necessary by the Owner's Agent for the execution of the construction warranty will be established/reviewed at this meeting. In connect these requirements and at the time of the Contractor's quality do ith 1+1 completion inspection, furnish the name, telephone number and a licensed and bonded company which is authorized to initiate and construction warranty work action on behalf of the Contractor of contact will be located within the local service area of the construction, be continuously available, and be responsive to a Owner inquiry on warranty work action and status. This requirem not relieve the Contractor of any of its responsibilities in co lress а d pursu This. int ted to Architect or uirement does in connect with other portions of this provisi on.

1.7.4 Contractor's Response to Construction Warranty Service Requireme

Following oral or written notification by the Owner's Agent, respondto construction warranty service requirements in accordance with the "Construction Warranty Service Priority List" and the three categories of priorities listed below. Submit a report on any warranty item that has been repaired during the warranty period. Include within the report the cause of the problem, date reported, corrective action taken, and when the repair was completed. If the Contractor does not perform the construction warranty within the timeframe specified, the Architect or Owner will perform the work and back charge the construction warranty payment item established.

- a. First Priority Code 1. Perform onsite inspection to evaluate situation, and determine course of action within 4 hours, initiate work within 6 hours and work continuously to completion or relief.
- b. Second Priority Code 2. Perform onsite inspection to evaluate situation, and determine course of action within 8 hours, initiate work within 24 hours and work continuously to completion or relief.
- c. Third Priority Code 3. All other work to be initiated within 3 work days and work continuously to completion or relief.

- a. One set of "as-designed" electronic CAD and BIM files in the specified software and format revised to reflect all amendments and the final contract PDF drawings. The CAD and BIM files are provided to enable preparation of as-built or as-constructed documents. If discrepancies exist between the CAD and BIM files and the contract PDF drawings, correct the CAD and BIM files to show the contract PDF drawings.
- b. A submittal register data file in comma separated value (CSV) format for import into the Resident Management System (RMS).
- c. Advanced Modeling Revit (2017), Navisworks, and Autodesk Civil 3D files for use in the development of the As-Built Model.

2.1.1 As-Built and Record Documents

DESCRIPT

For purposes of as-built and record documents, the Architect or Owner will provide the Contractor optical discs (CD or DVD) of Architect or Owner Furnished Architect or Owner Installed (GFGI) equipment and Architect or Owner Furnished Contractor Installed (GFCI) equipment for incorporation into the final record documents and record 3D models by the Contractor. Contractor to request the discs from the Owner's Agent a minimum of 30 calendar days priorto need. The discs will contain the following:

a. Electronic CAD and BIM files of the record GFGI and GECI equipment in software formats and versions compatible with the "as-designed" files distributed at the pre-construction conference.

Prepare the CAD drawing files in AutoCAD Release 2017 format compatible with a Windows operating system.

2.2.1 Additional Drawin

If additional drawings are required, prepare them using the specified electronic file format applying ERDC/ITL TR-12-6 and ERDC/ITL TR-12-1. The title block and drawing border to be used for any new final record documents must be identical to that used on the contract drawings.

2.2.1.1 Sheet Numbers and File Names

If a sheet needs to be added between two sequential sheets, append a Supplemental Drawing Designator in accordance with ERDC/ITL TR-12-6 (Adding a drawing sheet), and ERDC/ITL TR-12-1 (Adding or deleting drawing sheets and index sheet procedures).

2.3 CERTIFICATION OF EPA DESIGNATED ITEMS

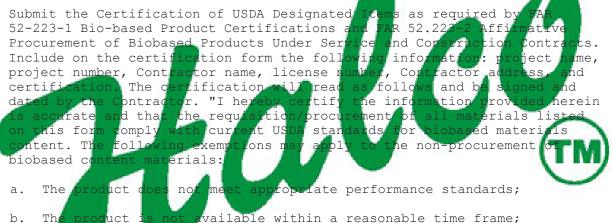

3.1.1 As-Built Drawing Markup Guidelines

Make comments and markup the drawings complete without reference to letters, memos, or materials that are not part of the As-Built drawing. Show what was changed, how it was changed, where item(s) were relocated and change related details. These working as-built markup prints must be neat, legible and accurate as follows:

- a. Use base colors of red, green, and blue. Color code for changes as follows:
 - Special (Blue) Items requiring special information, coordination, or special detailing or detailing notes.
 - (2) Deletions (Red) Over-strike deleted graphic items (lines), lettering in notes and leaders.
 - (3) Additions (Green) Added items, lettering in notes and l
- b. Provide a legend if colors other than the and blue are used.

c. Add and denote any additional equipment or material facilities, service lines, incorporated under As-Built Revisions if not alread shown in legend.

1. Use frequent written explanations on marku changes. Do not totally rely on graphic m

- e. Use legible lettering and precise and clear digital values when marking prints. Clarify ambiguities concerning the nature and application of change involved.
- f. Wherever a revision is made, also make changes to related section views, details, legend, profiles, plans and elevation views, schedules, notes and call out designations, and mark accordingly to avoid conflicting data on all other sheets.
- g. For deletions, cross out all features, data and captions that relate to that revision.
- h. For changes on small-scale drawings and in restricted areas, provide large-scale inserts, with leaders to the applicable location.
- i. Indicate one of the following when attaching a print or sketch to a markup print:
 - 1) Add an entire drawing to contract drawings
 - 2) Change the contract drawing to show
 - 3) Provided for reference only to further detail the initial design.

3.1.2 As-Built Drawings Content

Revise As-Built Drawings and Models in accordance with ERDC/ITL TR-12-1 and ERDC/ITL TR-12-6, and the Advanced Modeling Project Execution Plan (PxP).

Provide 2 sets of paper copies from PDF drawings to show the as-built conditions by red-line process during the execution of the project. Keep these working as-built markup drawings current on a weekly basis and at least one set available on the jobsite at all times. Changes from the contract drawings which are made during construction or additional information which might be uncovered in the course of construction must be accurately and neatly recorded as they occur by means of details and notes. Submit the working as-built markup drawings for approval prior to submission of each monthly pay estimate. For failure to maintain the working and final record drawings as specified herein, the Owner's Agent will withhold 10 percent of the monthly progress payment untilapproval of updated drawings. Show on the as-built drawings, but not limited to, the following information:

work to the Architect or Owner. Within 20 days of substantial completion of all phases of work, submit the final recorddocument package for the entire project. Submit one set of electronicCAD and BIM files, and one set of the approved working record PDF files on optical discs with two sets of prints. The CAD and BIM filesmust be complete in all details and identical in form and function to he CAD and BIM drawing files supplied by the Architect or Owner. Prepare AutoCAD, Revit, Navisworks, and Autodesk Civil 3D files for transmittal using e-Transmit. Make any transactions or adjustments necessary to accomplish this. The Architect or Owner reserves the right to reject any drawing files it deems incompatible with the customer's CADand BIM system. Paper prints, drawing files and storage media submitted will become the property of the Architect or Owner upon final approval. Failure to submit final record PDF drawing files, CAD and BIM files and marked prints as specified will be cause for withholdingany payment due under this contract. Approval and acceptance of finalrecord documents must be accomplished before final payment is made.

3.3 RECORD DOCUMENTS

Prepare final record documents after the completion of each definable phase of work as listed in the Contractor Quality Control Plan (Foundations, Utilities, Structural Steel, etc.) as appropriate for the project). Transfer the changes from the approved working as-built markup drawings to the original electronic BIM and CAD drawing files. These PDF drawing files are part of the permanent records of this project. Any drawings damaged or lost must be satisfactorily replaced at no expense to the Architect or Owner.

- a. Drawing revisions (include within change order price the cost to change working and final record drawings to reflect revisions) and compliance with the following procedures.
 - (1) Follow directions in the revision for posting descriptive changes.
 - (2) The revision delta size must be 5/16 inch unless the area where the delta is to be placed is crowded. Use a smaller size delta for crowded areas.
 - (3) Place a revision delta at the location of each deletion.
 - (4) For new details or sections which are added to a drawing, place a revision delta by the detail or section title.
 - (5) For minor changes, place a revision delta by the area changed on the drawing (each location).

Provide four electronic copies of the Operation and Maintenance Manual files and two hard copies of the Operation and Maintenance Manuals. Submit to the Owner's Agent for approval within calendar days of the Beneficial Occupancy Date (BOD). Update and resubmit files for final approval at BOD.
